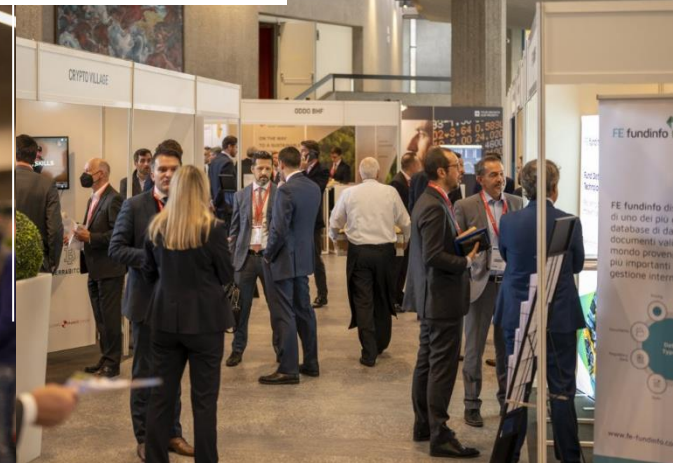

FinLantern A.I. lead generation system

- 1 Target identification:** the Sponsor provides a number of keywords to identify his products/services and target audience.

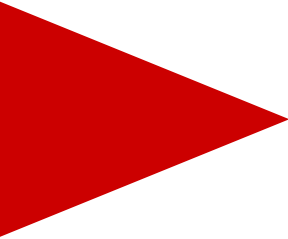

Eva Vlaardingerbroek (1996) is a Dutch political and cultural commentator and legal philosopher. She has been regularly featured on Mark Steyn, Tucker Carlsson and many other media outlets across the world. She received her masters with honors from Leiden University in 2019 and after getting involved in Dutch politics, she – the dubbed ‘shield maiden of the far right’ – has made it her mission to defend freedom and Western civilization and culture. She’s particularly known for her fight for the Dutch farmers and her stance against immigration and the European Union in her viral speeches at CPAC Hungary. Eva has over 1.5 million followers on social media platforms including X and Instagram.

At the Lugano Finance Forum, keynote speaker Eva Vlaardingerbroek will deliver a powerful speech on why Switzerland’s model of democracy, freedom, and economic independence stands in stark contrast to the European Union — and why the EU is far from being a model worth imitating.

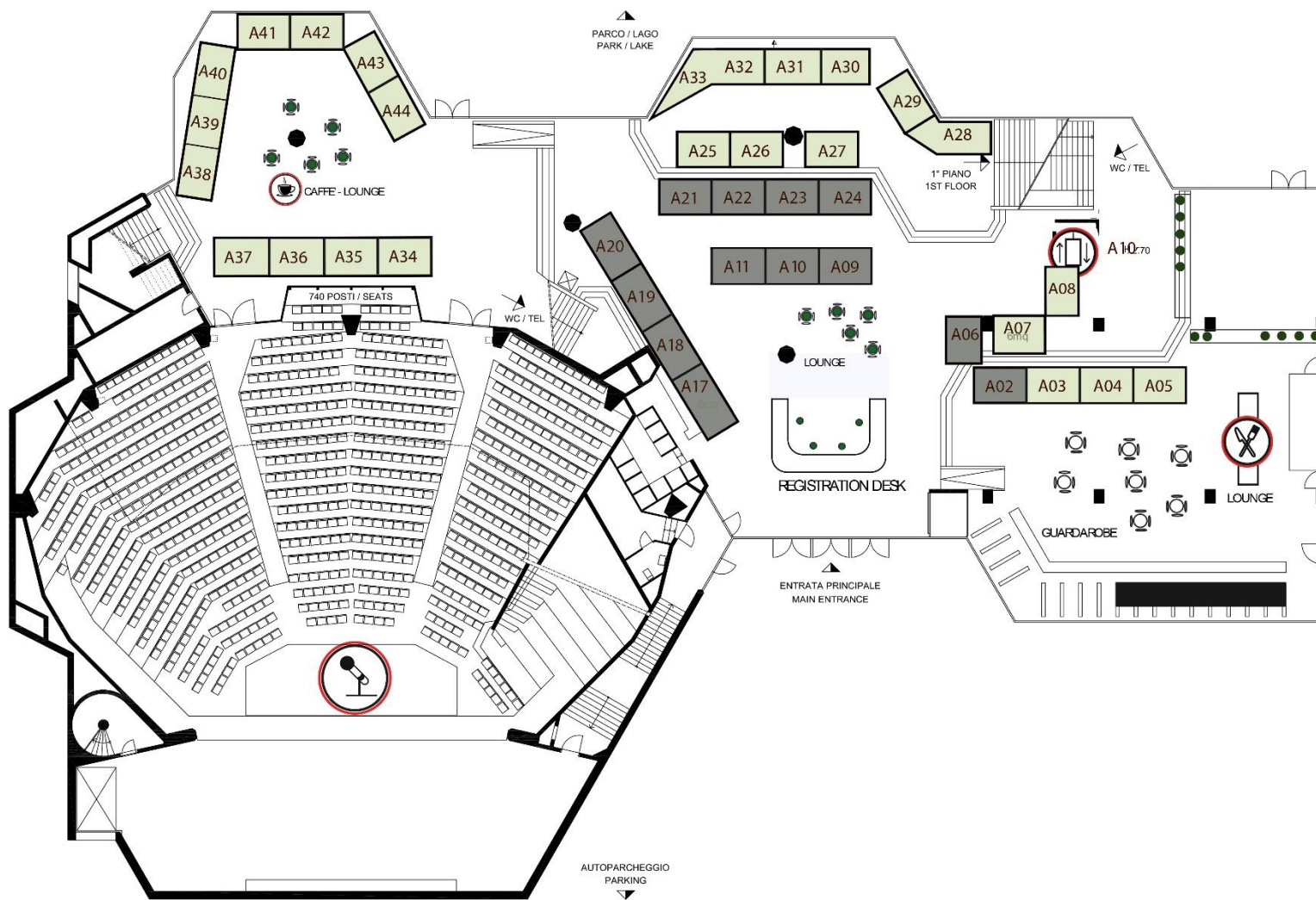

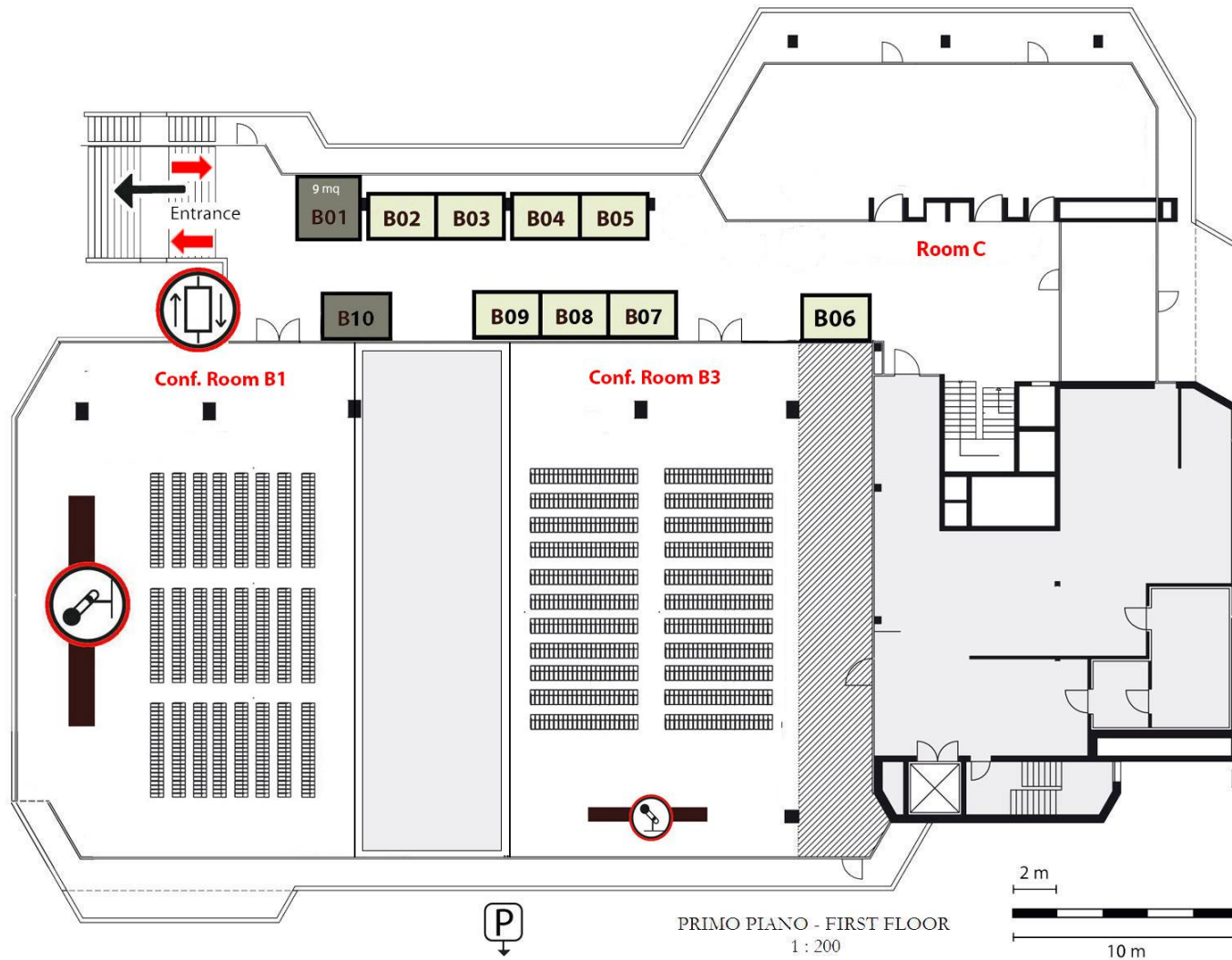
